VILLAGE OF MAPLETON ORDINANCE NO. 2018-06-13- $\cancel{\boxtimes}$ 2

An Ordinance Amending the Village Code to Allow Limited Fireworks Sales in the Village of Mapleton

WHEREAS, an area business has requested the Village allow fireworks sales at a Village business:

WHEREAS, THE Corporate Authorities of the Village of Mapleton deem it necessary and in the best interest of the Village to amend the Village Code to allow fireworks sales by businesses with a valid license from the Illinois State Fire Marshall; and

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Mapleton, Peoria County, Illinois as follows:

Section 1. The foregoing recitals are hereby incorporated as though fully set forth herein.

Section 2. That Chapter 9, Peddlers, Solicitors, Etc. of the Mapleton Village Code is hereby amended to add a section 9-6 Temporary Fireworks Sales to read as follows:

TEMPORARY FIREWORKS SALES

Except as hereinafter provided it shall be unlawful for any person, firm, copartnership, or corporation to knowingly offer for sale, expose for sale, or sell at retail any fireworks; provided that the President and Board of Trustees shall have power to grant permits for supervised public displays of fireworks or grant permits for fireworks sales issued by the State Fire Marshall of the State of Illinois. There will be a \$100 application fee and is contingent upon providing proof of insurance and a copy of the permit from the state Fire Marshall.

Section 3. This Ordinance shall become effective ten (10) days after its passage, approval, and publication as required by law.

Section 4. Should any portion of this Ordinance be held invalid or unenforceable for any reason, the invalidity or unenforceability of such portion shall not affect any of the remaining portions of this Ordinance.
