NEW CONSTRUCTION CHECKLIST

The following items are required for the application to be processed. Exemptions may apply. Two inspections will be required of all new constructions. All "concealed mechanical work ad framing" must be inspected and approved before permission to cover will be given. A "final" inspection is required upon completion of all permitted work prior to the expiration of the permit. All work must be visible to the inspector. All inspection fees will be paid by the applicant and included with the submission of the completed Certificate of Occupancy Permit application.

Applicant is required to obtain permit(s) prior to starting construction. Applicant is required to adhere to the current Building Codes and to call for all required inspections 48 HOURS prior to the needed inspection.

Failure to submit all items for plan review shall cause the permit application to be rejected. Violation of Village of Mapleton Codes will subject applicant to appropriate penalty.

Structure tested for appropriate air sealing. A passing Blower Door Test required for New Construction. Additions/Remodeling may opt to provide a passing blower door test or a visual inspection per R402.4.1.3

Exceptions for Additions/Remodeling: R402.4.1.3 Visual Inspection Option for Additions, Alterations, Renovations or Repairs. Building envelope tightness and insulation installation shall be considered acceptable when the items in Table R402.4.1.1, applicable to the method of construction, are field verified. When required by the code official, an approved third party, independent from the installer, shall inspect air barrier and insulation installation.
