## ORDINANCE NO. 2018-12-13-01

### **An Ordinance Levying the Annual Municipal Tax for the Village of Mapleton, Peoria County, Illinois For the fiscal year beginning May 1, 2018 Ending April 20, 2019**

WHEREAS, the President and Board of Trustees of the Village of Mapleton, Peoria County, Illinois, did on the 13<sup>th</sup> day of December, 2018, pass the Annual Appropriation Ordinance of said Village of Mapleton for the fiscal year beginning May 1, 2018, and ending April 30, 2019, the total amount of appropriation for general corporate purposes, exclusive of election costs, being One Hundred Thirty-Four Thousand Three Hundred Dollars (\$134,300); said Ordinance is now in full force and effect and is on file in the office of the Village Clerk of the Village of Mapleton; and

WHEREAS, no public hearing was necessary on the proposed Tax Levy Ordinance in accordance with the provisions of "The Truth in Taxation Act" (35 ILCS 200/18-55 et seq.), as amended;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MAPLETON, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

Section One. That the sum of Forty-One Thousand Six Hundred Forty-Six Dollars (\$41,646) be and the same is hereby levied upon all the taxable property in the Village of Mapleton, Peoria County, Illinois as a tax for the use of the Village of Mapleton for corporate purposes for the fiscal year beginning May 1, 2018, and ending April 30, 2019, as follows:

For General Corporate Purposes (65 ILCS 5/8-3-1)	\$19,000

Total Tax Levy	\$41,646

The same being the amount of money heretofore appropriated for corporate purposes of said Village of Mapleton for said fiscal year less the amount to be derived from sources other than taxes levied for corporate purposes, said several purposes and uses for which said tax is levied and the amount levied and appropriated as aforesaid for each of said corporate uses and purposes being as follows:

Section Two. That the County Clerk of the County of Peoria and State of Illinois is hereby authorized and direction to extend the amount of said taxes levied by this Ordinance as follows:

For the total sum of Forty-One Thousand Six Hundred Forty-Six Dollars (\$41,646) said levy to be made upon all taxable property within the corporate limits of the said Village of Mapleton for the fiscal year beginning May 1, 2018 and ending April 30, 2019.

Section Three. The Village Clerk of the Village of Mapleton is hereby directed to file a certified copy of this Ordinance with the Office of the County Clerk of the County of Peoria and State of Illinois on or before the last Tuesday of December, 2018.

Section Four. If any section or part of this Ordinance is for any reason held invalid, it shall not affect the validity of the remaining portions of this Ordinance.


Section Five. This Ordinance shall be in full force and effect from and after its passage, approval and filing as provided by law.



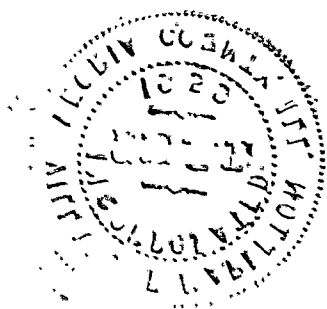


