WHEREAS, the Village Board of the Village of Mapleton finds that it is in the best interest of the Village to change the meeting schedule.





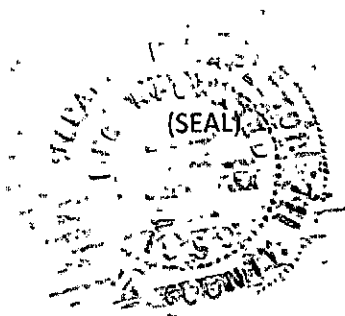
