

**VILLAGE OF MAPLETON**  
**ORDINANCE NO. 2020-05-13-01**

**AN ORDINANCE AMENDING THE VILLAGE CODE CHAPTER 14 WATER SERVICE CHARGES AND GARBAGE SERVICE CHARGES TO CLARIFY SECTIONS 14-7, 14-8, 14-9 AND 14-10**

**WHEREAS**, the Village Board of the Village of Mapleton has the authority to enact such regulations as it deems are in the best interest of public health and welfare; and

**WHEREAS**, the Village Board of the Village of Mapleton deems it to be in the best interests of the Village to change provisions regarding Chapter 14, Water Service Charges and Garbage Service Charges; to Change the Water Rate in order to clarify Provisions to Sections 14-7, 14-8, 14-9, and 14-10;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MAPLETON, PEORIA COUNTY, ILLINOIS AS FOLLOWS:**

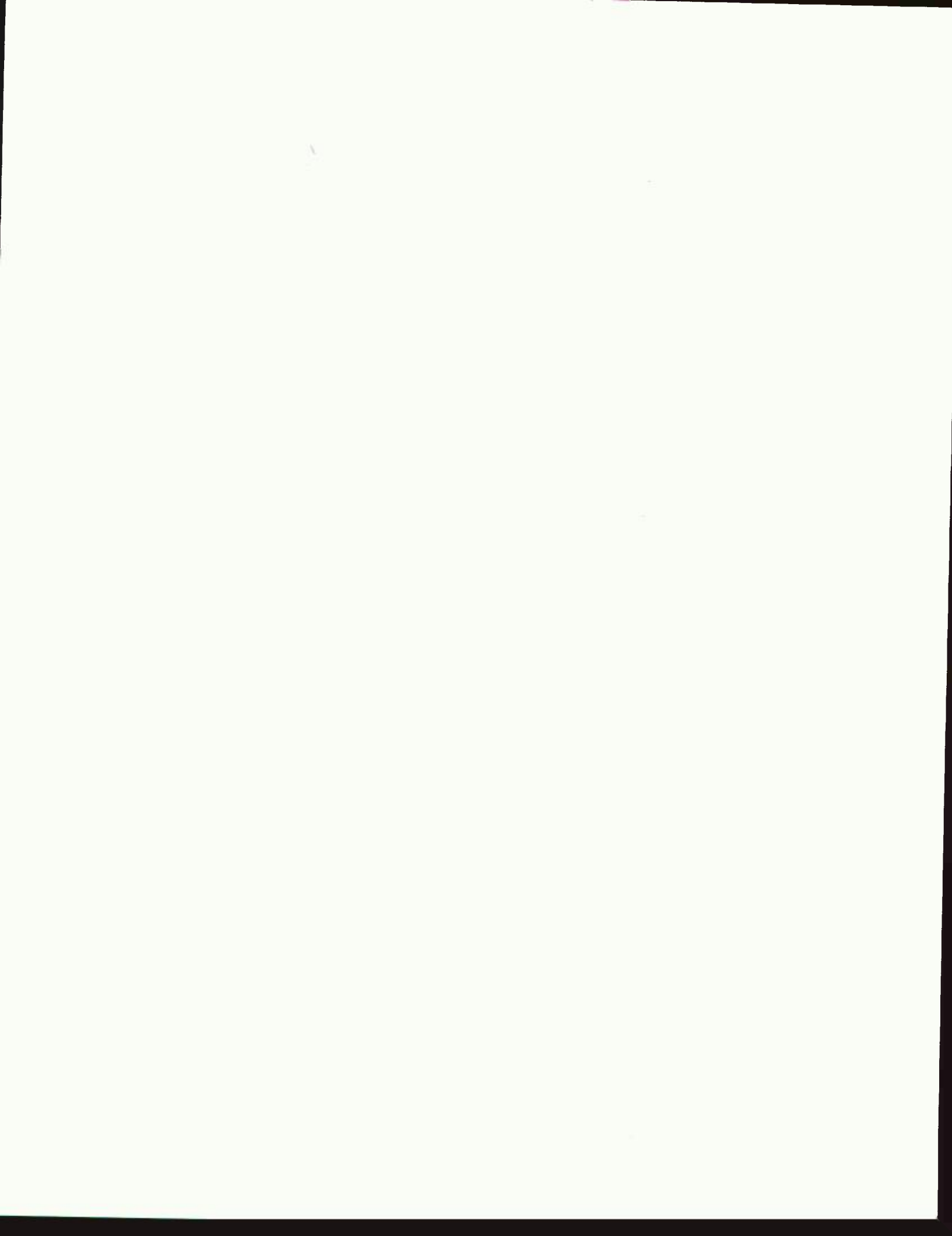
Section 1: The foregoing recitals are hereby incorporated herein as though fully set forth.

Section 2: The following Chapter 14, Water Service Charges and Garbage Service Charges, Sections 14-7, 14-8, 14-9, 14-10 and 14-11, of the Mapleton Village Code are hereby amended to read as follows:

Section 14-7: Basic User Charge: There shall be and there is hereby established a basic user charge of \$20.00 per month to be applied to all users to recover O, M & R costs, or any portion thereof.

Section 14-8: Debt Service Charge: There shall be and there is hereby established a debt service charge of \$10.00 per month, or any portion thereof.

Section 14-9: Capital Improvement Charge: There shall be and is hereby established a capital improvement charge of \$7.10 per month to each user of the water facility, or any portion thereof.



Section 14-10. A minimum charge of \$37.10 per month or any portion thereof shall be applied to all users whose water consumption does not exceed 2,000 gallons per month. This minimum charge consists of \$19.00 for O, M & R costs, \$10.00 for Debt Service costs and \$7.10 for capital improvement costs.

Section 3: This ordinance shall be effective on the date of its passage and publication as provided by law.
