

ORDINANCE NO. 2023-05-10-1

VILLAGE OF MAPLETON, ILLINOIS

ORDINANCE AMENDING CHAPTER 14, WATER SERVICE CHARGES,
OF THE MAPLETON VILLAGE CODE

WHEREAS, the Village is authorized to establish charges for late payments of water charges by Section 11-117-12 of the Illinois Municipal Code; and

WHEREAS, the Village Board has determined that there is a need to provide for the reimbursement to the Village of costs and expenses incurred by the Village for the collection of delinquent water charges; and

WHEREAS, the Village Board deems it necessary and in the best interest of the Village to amend the Mapleton Village Code as provided below;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE VILLAGE BOARD OF THE VILLAGE OF MAPLETON, PEORIA COUNTY, ILLINOIS AS FOLLOWS:

Section 1: The Village Board hereby finds as fact the recitals set forth above.

Section 2: Sections 14-7, 14-8, 14-9 and 14-10 of the Village Code shall be deleted in their entirety, and the following sections shall be substituted in their place:

14-7. Basic User Charge: There shall be and there is hereby established a basic user charge of \$26.00 per month or any portion thereof to be applied to all users to recover O, M & R costs.

14-8. Debt Service Charge: There shall be and there is hereby established a debt service charge of \$5.00 per month or any portion thereof to each user of the water facility whose average monthly consumption during the previous 12 months is less than 100,000 gallons. The debt service charge for users whose average monthly consumption during the previous 12 months is equal to or greater than 100,000 gallons and less than 2,000,000 gallons shall be \$150.00 per month or any portion thereof. The debt service charge for users whose average monthly consumption during the previous 12 months is equal to or greater than 2,000,000 gallons shall be \$600.00 per month or any portion thereof.

14-9. Capital Improvement Charge: There shall be and there is hereby established a capital improvement charge of \$4.00 per month or any portion thereof to each user of the water facility whose average monthly consumption during the previous 12 months is less than 100,000 gallons. The capital improvement charge for users whose average monthly consumption during the previous 12 months is equal to or greater than 100,000 gallons and less than 2,000,000 gallons shall be \$150.00 per month or any portion thereof. The capital improvement charge for users whose average monthly consumption during the previous 12 months is equal to or greater than 2,000,000 gallons shall be \$600.00 per month or any portion thereof.

14-10. A minimum charge of \$35.00 per month shall be applied to all users whose water consumption does not exceed 2,000 gallons per month. This minimum charge consists of \$26.00 for O, M & R costs, \$5.00 for debt service costs and \$4.00 for capital improvement costs.

Usage in excess of 2,000 gallons per month will be charged at the following rates per 1,000 gallons:

<u>Monthly Consumption</u>	<u>Rate</u>
2,001-10,000 gallons	\$12.85
10,001-25,000 gallons	\$14.45
25,001-50,000 gallons	\$14.00
50,001 – 100,000 gallons	\$12.60
100,001 and over	\$11.75

These rates consists entirely of O, M & R costs, and no portion goes toward debt service costs or capital improvement costs.

Section 3: This ordinance shall be effective on June 1, 2023.
